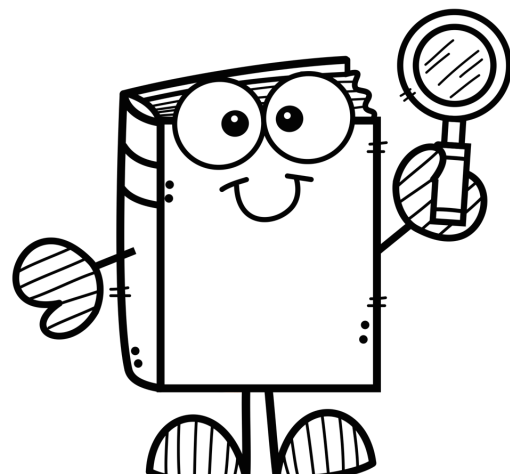

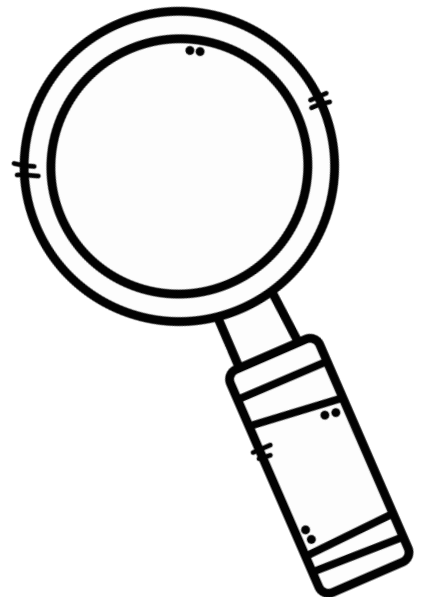

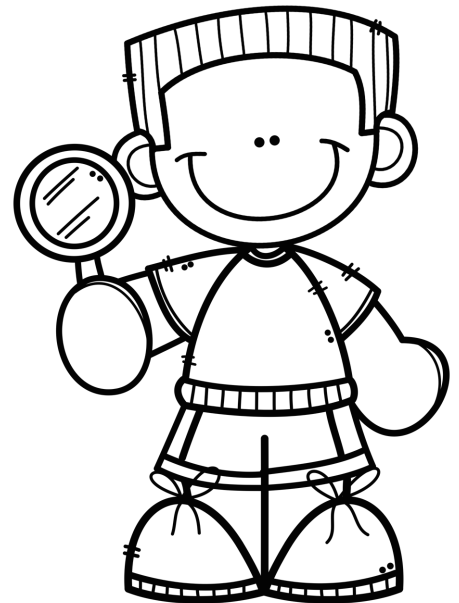

YOUR TEAM MUST PREPARE FACTS TO PROVE HAZEL HARMAN IS INNOCENT OF THE CRIME

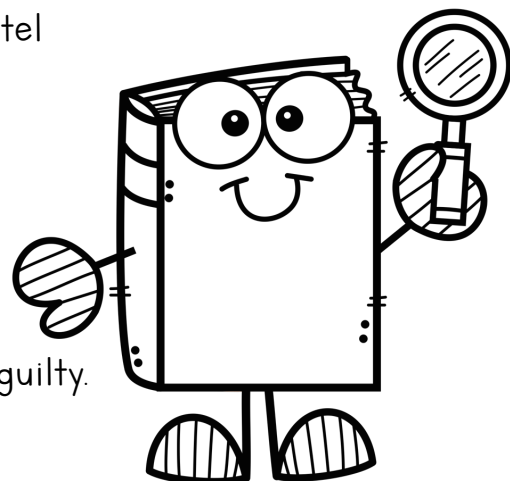

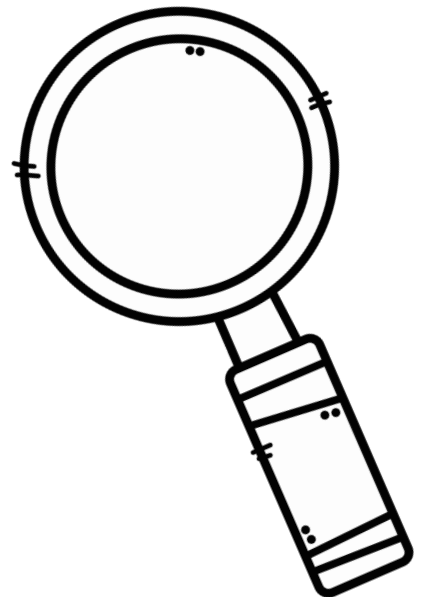

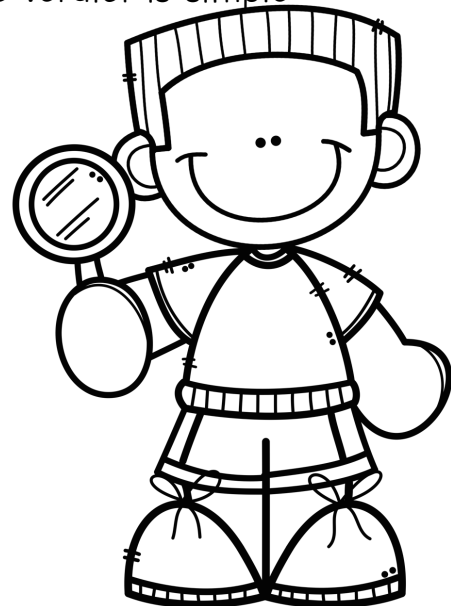
STAND, WALK AROUND THE TABLE AND LOOK AT THE JUDGE AND JURY.

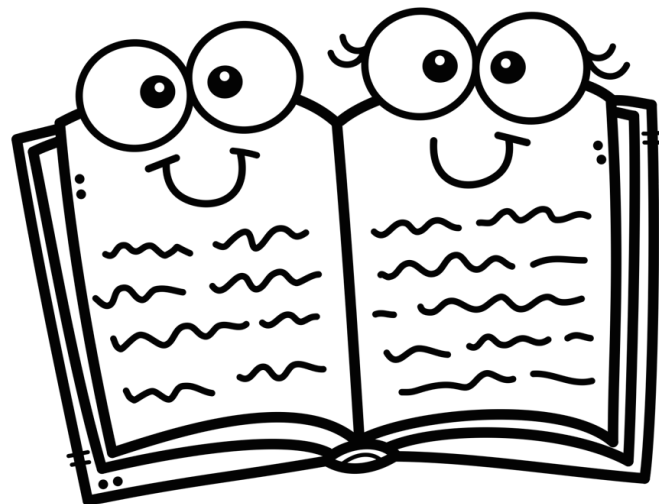

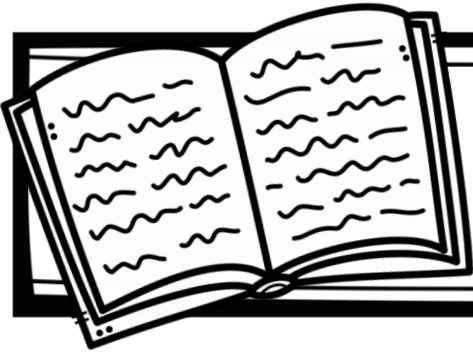

THE PROSECUTION WILL CALL THEIR WITNESS

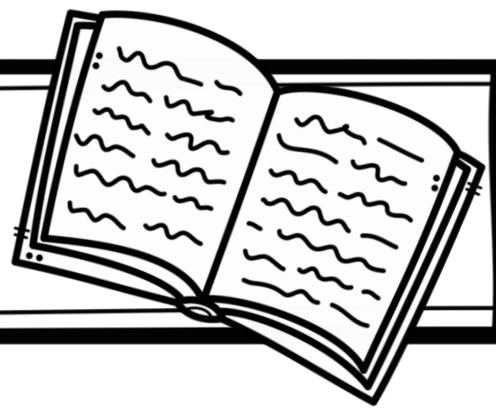

You will give the "VERDICT" paper to the first jury.

AFTER DELIBERATION

All rise. The jury has now taken its decision.

The session is now adjourned.
